#### **CAMP RULES AND AGREEMENT**

On the premise that A2Z s.r.l. (hereinafter A2Z) organizes summer camps for campers aged 6 to 17; that camps will run in the following periods in 2025: Junior Discovery from June 8 to July 26, Outdoor Exploration from June 15 to July 26, Sea Quest from June 29 to July 19, and Alphabet City from July 6 to July 26; that it is the intention of the undersigned to adhere to one or more of these initiatives; that this Enrollment Form is a contract governed by Italian law;

it is agreed that:

#### Art. 1 - PREMISES

The abovementioned premises constitute an integral and essential part of the agreement.

#### Art. 2 - PARTICIPATION

Participation in Junior Discovery camp is open to campers aged 6 to 12.

Participation in Outdoor Exploration camp is open to campers aged 12 to 17.

Participation in Sea Quest camp is open to campers aged 12 to 17.

Participation in Alphabet City camp is open to campers aged 12 to 17.

Registration for each camp is formalized by completing this enrollment form in all its parts together with an agreed deposit payment. Participation is subject to payment in full.

#### Art. 3 - PARTICIPANTS

There will be a minimum of 15 participants and a maximum of 40 participants per week within each program, Junior Discovery, Outdoor Exploration and Alphabet City. Sea Quest will have a minimum of 6 and a maximum of 8 participants per boat per one-week period.

#### Art. 4 - FEES

The final price is calculated as the total of all the elements of the camp (stay, transfers, excursions) minus any applicable discounts, subject to the approval of A2Z. Payment may be divided in two: a deposit payment equal to 50% of the total price payable within 10 days of registration, and the remaining balance payable by April 30, 2025. In the event a camper is enrolled after this date, the full balance is due at the time of registration, as mentioned in Art. 15.

The deposit paid at the time of enrollment represents a down payment necessary to hold a spot and is non-refundable, except in case of the cancellation of the camp on the part of A2Z, as mentioned in Art. 5, or any withdrawals in accordance with the parameters stated in Art. 7.

The enrollment price covers the cost of registration, 3<sup>rd</sup> party insurance, an English language initial assessment test, all academic materials, accommodation, all living expenses during the participant's stay, sports and other activities, English lessons with qualified English mother-tongue teachers (or equivalent other academic program), the use of the facilities and equipment, unlimited soft drinks, three meals and two snacks per day, daily room cleaning service, plus all extras selected such as transfers and/or excursions.

#### Art. 5 - CAMP CANCELLATION

A2Z reserves the right to cancel the camp if participants don't reach the minimum number set out in Art. 3, in which case the camper has the right to a full refund of all fees paid, without exception.

#### Art. 6 – CHANGES

The organizers reserve the right to make changes to the program before and/or during the camp in the event of technical or organizational needs, or under any circumstances that may require it.





#### Art. 7 - WITHDRAWAL (BEFORE OR DURING THE CAMP)

- · For cancellation of participation 30 or more days prior to the start of camp, the participant will receive a 100% reimbursement of fees.
- For cancellation of participation between 29 and 15 days prior to the start of camp, the participant will receive a 50% reimbursement of fees.
- For cancellation of participation less than 15 days prior to the start of camp, or for withdrawal from camp once it is underway, the participant is not eligible for any refund.

Please note that the start of camp is intended as the first day of the entire booked experience, whether spanning one, two, or more weeks. Once reserved, a multi-week experience cannot be fractioned back into individual weeks, and the above cancellation policy will therefore apply to the fees of the entire experience as booked.

For signatories worried about the possibility of canceling their participation within 30 days of the camp's start, we highly recommend securing a *cancellation-for-any-reason* insurance policy.

#### Art. 8 – DISMISSAL FROM THE CAMP

A2Z reserves the right to dismiss any participant who shows an inability to adapt to group life and who causes any serious disturbance to the activities with behavior that is not in keeping with the spirit of the camp. Any serious violation of "common sense" rules, such as damage to property, a lack of respect for staff of any kind and to any degree, or disrespectful behavior during activities and recreation time will result in the participant's immediate dismissal from camp. Regardless of the unpleasant nature of dismissal, the abovementioned measures are necessary in order to guarantee the health, balance and protection of individual participants and the community as a whole. In the case of dismissal, the participant will not have the right to any refund.

#### Art. 9 - OBJECTS NOT PERMITTED

The following objects are **forbidden**: radios, CD/DVD players, mp3 players, penknives, videogames, iPads, food, computers, TVs, fireworks, sweets/candy, chewing/bubble gum, cosmetics, razors, cigarettes, e-cigs, laser pointers, water or air guns and other objects that could be considered dangerous.

If any of the abovementioned objects or other similar objects that the staff consider unsuitable are brought to the camp, they will be confiscated and returned to the participant or their parents at the end of camp.

#### Art. 10 - MOBILE PHONES

Mobile phone usage at camp is governed by specific rules for each program. Generally, phones can be distracting and may interfere with overall experiences. To foster immersion in the program, we require campers to adhere to the following guidelines:

- Junior Discovery: Campers' phones are held by the camp director and distributed during designated call times on Tuesdays and Thursdays at 2 pm.
- **Outdoor Exploration**: Campers' phones are kept at the Phone-Station at all times except during call times on Tuesdays at 2 pm and Thursdays at 6pm.
- **Sea Quest**: Campers are required to leave phones in their cabins, except call times on Tuesdays and Thursdays at 2 pm, and when on land visiting the islands.
- Alphabet City: Campers are permitted to carry phones during excursions but must turn them off during cultural visits, classes, mealtime, or whenever instructed by an Alphabet counselor.

#### Art. 11 - RECEPTION AND DEPARTURE

On arrival, participants are taken into the care of the camp staff directly from the parent or legal guardian. At the end of camp, participants are only allowed to be picked up by the parent or legal guardian, or a person in possession of the necessary written authorization signed by one of the participant's parents or legal guardians and on presentation of a valid form of identification.

#### Art. 12 - SWIMMING ABILITY

All participants must be competent swimmers.

#### Art. 13 - INSURANCE

Enrollment includes 3rd party liability coverage only.

#### Art. 14 - LOST OR DAMAGED PROPERTY

A2Z is not liable for the loss, theft, or damage of participants' personal belongings or valuables before, during, or after camp activities.

If any camp equipment, boats, residences, classrooms, or other facilities are damaged due to a camper's intentional or reckless actions, the camper's family will be responsible for the cost of repairs or replacement.

#### Art. 15 - OBSERVATIONS AND JURISDICTION

Any complaints and/or observations by parents should be communicated solely and exclusively to the Camp Director in charge of the summer camp.

Any dispute regarding the validity, interpretation, execution and/or termination of the contract shall be referred to the exclusive jurisdiction of the Court of Rome.

#### Art. 16 - PROCESSING OF PERSONAL DATA

I, the undersigned, authorize A2Z to process, archive and use my personal data for the sole purpose of processing the enrollment to the camp and keep me up-to-date with its programs. In accordance with law 675/96 for the protection of privacy, I may request at any time the deletion or rectification of data kept by A2Z
